Object: Agreement for the authorization to use your images

Dear Sir, Dear Madam _____,

We make reference to the videos and/or the photographs which will be made or taken by and/or on behalf of our Company on the occasion of the P ZERO EXPERIENCE FRANCE to be held at Paul Ricard Circuit, on 3rd July 2026 (the “**Event**”), which might display your image (said videos and photographs, the “**Material**”).

Since your image is or shall be displayed in the Material, the following is agreed:

A. Authorization to the use of your image

1. Hereby you irrevocable:

- i) authorize our Company to use your image as part of the Material; and
- ii) to use and have used the Material, displaying your image, within and for the purposes of our company’s institutional and/or promotional communication activity relating to the Event, through any means and channels (including –without limitation- Pirelli website, Pirelli intranet, and Pneus Pirelli S.A.S. social media channels), without limits on time, space and number of issues, any other use of the Material, displaying your image, for commercial purposes (i.e.: in direct association with products and/or services of our company and/or other companies of the Pirelli Group) to be intended excluded and prohibited.

B. Data protection notice ex art. 13 of EU Regulation no. 679/2016 –General Data Protection Regulation (“GDPR”)

- 2.** Your personal data, including images of you, will be processed by our Company as data controller, for the purposes indicated in paragraph A.1. Such data processing, which also includes the publication or dissemination of the Material containing the images of you through the communication channels indicated above, is based on this agreement and on the irrevocable authorization you are granting us to use the above images for the purposes and activities indicated in paragraph A.1. The aforementioned personal data will be processed by our authorized personnel and kept in our electronic filing system for the entire time of storage of the Material containing also images of you.
- 3.** We remind you that it is entirely up to you whether or not to submit your personal data for the above-mentioned purposes but in case you refuse to provide your data, we will not be

allowed us to conclude this agreement and no publication and/or use of the Material containing images of you will be permitted.

In accordance with the provisions of Law no. 78-17 of January 6, 1978, "Informatiques et Libertés", as amended by Law no. 2018-493 of June 20, 2018 on the protection of personal data and Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, any person who communicates personal data benefits from a right of access, rectification, deletion, opposition, limitation of processing and a right to portability of personal data concerning him or her with Pirelli.
