In particular, by signing this release, I hereby declare that I am able to drive vehicles of all kinds, expressly including the so – called “Supercar” on the track and that I will do it responsibly and that I will use the vehicles entrusted to me with caution and at my own risk and that I am in physical and psychological conditions suitable for participating in the Event, assuming all related responsibilities.

I undertake to respect any applicable laws and regulations, including the ones regarding the track and those governing driving (the “**Driving Code**”) and, in case of any breach of said Driving Code, to entirely bear the responsibility for it, including the payment of any amounts/ sanctions set forth by the applicable law.

I unconditionally and irrevocably agree to release and save Pirelli harmless from any damage, cost, loss, liability or expenses (including legal fees) with respect to any claims arising out of or in any way connected with my participation to the Event, both during the road tour(s) and during the rounds at the circuit and hereby waive any claim or action against Pirelli, including those that may be brought by third parties, in this regard.
