**P ZERO™ EXPERIENCE REGULATIONS
PAUL RICARD CIRCUIT
3rd July 2026**

These P ZERO™ Experience regulations (the “**Regulations**”) must be respected by the people who wish to attend the P ZERO™ Experience, and specifically accessing the track and paddock in the Paul Ricard Circuit (Circuit Paul Ricard), located at 2760 Rte des Hauts du Camp, 83330 Le Castellet, FRANCE (hereinafter, the “**Circuit**”).

**1. REQUIREMENTS FOR THE ACCESS TO THE TRACK AND PADDOCK -
PROHIBITIONS**

For the purposes of these Regulations, “**Driver**” means the natural person who will attend the P ZERO™ Experience following the purchase of the P ZERO™ Experience Package by such person or by any other third party, or the Voucher’s Beneficiary, or the Additional Driver, who will drive the car - stated in the registration/purchase phase - at the Circuit.

Before the start of the P ZERO™ Experience, each Driver will be provided with the programme of activities on the track they must comply with. Each Driver must comply with the instructions provided by the person in charge of track activities and the personnel appointed by PIRELLI.

1.1

To be able to participate in the driving sessions of the P ZERO™ Experience the Driver must:

- (a) have at least 21 years of age and hold a driving licence, currently valid, issued at least 36 months earlier, not subject to suspension or other sanctioning measure;
- (b) guarantee that the car used during the P ZERO™ Experience (hereinafter, the “**Car**”) is the same selected during the registration/purchase phase of the P ZERO™ Experience and that the Car is compliant with all the legal provisions in force, including having passed any necessary tests required by current legal regulations;
- (c) guarantee that the Car does not have any non-approved replacement part of component, and/or any such component not specified in the Car registration certificate (logbook) (where necessary);

- (d) guarantee that the Car has adequate insurance coverages;
- (e) wear his/her own validly homologated automotive helmets and balaclavas and fasten the seats belts;
- (f) have signed the "Paul Ricard Circuit Documents ";
- (g) have signed the assumption of liability documents of the Circuit and of PIRELLI;
- (h) show a written declaration (in case the Driver will participate at the P ZERO™ Experience with a private Car registered to a third party) by which the Driver has the authorization to drive it and signed by the registered owner of the Car (as stated in the logbook).

1.2

It is strictly prohibited for any Driver to access the track and/or paddock in a psychically altered state (merely as an example, due to having consumed alcoholic drinks or drugs that can reduce concentration/induce sleepiness), until the driving activities have concluded.

1.3

It is strictly prohibited for any Driver to use a vehicle other than the Car indicated in the Pass to be shown upon entry.

1.4

Drivers are allowed, to transport a Companion as a passenger on the Car involved in the track sessions under the following conditions:

- (a) the passenger must be at least 16 years of age;
- (b) the passenger must sign the Driver release of Pirelli;
- (c) the passenger must sit next to the Driver;
- (d) the passenger must wear his/her own validly homologated automotive helmet and balaclava and fasten the seat belts.

It is absolutely forbidden for the Drivers to start any track session with a passenger, in the absence of delivery to PIRELLI of the duly completed Driver release

1.5

The P ZERO™ Experience Package is purchased on an individual and personal basis; it may in no way be transferred to third parties.

2 COMPANIONS AND ADDITIONAL DRIVER

2.1

The Driver expressly acknowledges and accepts that:

- (i) only 1 (One) Additional Driver is allowed, exception made for Voucher's Beneficiary for whom NO Additional Driver is allowed;
- (ii) the maximum number of Companions is 3 (three);
- (iii) children under 16 are not allowed to access to the P ZERO™ Experience and
- (iv) in the event the Companion(s) is/are underage (i.e. from 16 to 17 years old), a supervising adult Companion must also be present (included in the maximum number of 3 accompanying persons).

2.2

The Driver agrees that he/she shall enforce that his/her Companion(s) will respect, under penalty of exclusion from the P ZERO™ Experience pursuant to the following section 3.1, these Regulations and the " Paul Ricard Circuit Documents " that apply to them.

3 RIGHT OF EXCLUSION

3.1

PIRELLI reserves the right to exclude from participation in the P ZERO™ Experience any Driver, who does not respect the provisions of paragraph 1 and/or paragraph 2, who has made false statements or not presented the documentation requested for the registration process, capable of proving their possession of said requirements, or whose Car does not match the description in the "Pass" to be shown upon entry. PIRELLI also reserves the right to exclude from the participation those accompanying persons who do not have the requisites referred to in paragraphs 2.1 and 2.2 and/or do not comply with the " Paul Ricard Circuit Documents " .

3.2

At any time, for serious or repeated breaches of the instructions received from the appointed personnel of PIRELLI and/or the Circuit, or for repeated behaviours that might compromise the safety in the activities and/or the correct delivery of the service to the other participants, persons responsible for such behaviour may be excluded from the programmed activities. In case of this "disciplinary" exclusion, there will be no reimbursement of the amount paid.

4 COSTS NOT INCLUDED

Board and lodging costs of any kind, costs for extra services, costs of travelling to and from the Circuit, fuel, maintenance and insurance costs for own Cars and all those costs not specifically mentioned in the terms and conditions of sale of P ZERO™ Experience Package and Gift Voucher are not included in the registration cost.

5. LIABILITIES OF THE DRIVER

5.1

The Driver assumes full liability, in all eventualities, for the truthfulness of the information provided at the time of registration and in any subsequent request made by PIRELLI, the Circuit and/or the operators of the P ZERO™ Experience.

5.2

Participation in the P ZERO™ Experience is at the Driver's own risk. The vigilance of the staff of PIRELLI and of the Circuit during the activities in no way constitutes assumption of liability by the personnel in question or by PIRELLI for any damages caused by the Driver and/or his/her Companions (if any).

5.3

The Driver assumes any and every liability, without exclusion or exception, in civil, criminal or administrative proceedings, for any damage to things or to people, including those transported, and for any breach of the current regulations as a result of the use of the vehicles in question.

5.4

The Driver undertakes to pay directly or, otherwise, to reimburse the sums requested to him/her, or that the Driver might be sentenced to pay as a result of accidents, incidents, or breaches as stated above.

6. TEST DRIVES OR HOT LAPS WITH CAR MANUFACTURES

The Driver and/or any of his/her Companion(s) who wish to attend any activities (including test drives or hot laps) with the car manufacturers attending the P ZERO™ Experience shall
