



**P ZERO™ EXPERIENCE CENTRAL EUROPE 2026  
REGULATIONS  
Red Bull Ring Circuit**

11<sup>th</sup> September 2026

In order to access the track, the paddock and the ancillary facilities at the Red Bull Ring circuit located in Red Bull Ring Strasse 1, 8724 Spielberg, Austria (hereinafter, the “**Circuit**”) to make use of the P ZERO™ Experience Package acquired, the following regulations must be respected (the “**Regulations**”).

**1. REQUIREMENTS FOR ACCESS TO THE TRACK AND PADDOCK - PROHIBITIONS**

Before the start of the P ZERO™ Experience, each Driver (where, for the purposes of these Regulations, “**Driver**” means the natural person who will attend the P ZERO™ Experience following the purchase of the P ZERO™ Experience Package by such person or by any other third party, or the Voucher’s Beneficiary, or the Additional Driver, who will drive the car - stated in the registration/purchase phase - at the Circuit), will be provided with the programme of activities on the track with which he/she must comply. Each Driver must comply with the instructions provided by the person in charge of track activities and the personnel appointed by PIRELLI.

**1.1** To be able to participate in the track driving sessions, the Driver must:

- (a) have at least 21 years of age and hold a driving licence entitling them to drive vehicles, currently valid, issued at least 36 months earlier, not subject to suspension or other sanctioning measure;
- (b) guarantee that the vehicle used during the P ZERO™ Experience is the same vehicle selected during the registration/purchasing phase on the website dedicated to the sale of the P ZERO™ Experience (hereinafter, the “**Vehicle**”) and is compliant with all the legal provisions in force, including having passed any necessary tests required by current legal regulations;
- (c) guarantee that the Vehicle does not have any non-approved replacement part or component, and/or any such component not specified in the vehicle registration certificate (log book) (where necessary);
- (d) guarantee that the Vehicle has a maximum sound power level of  $\leq 122$  dbA;
- (e) guarantee that the Vehicle has adequate insurance coverages;
- (f) wear his/her own validly homologated automotive helmets and balaclavas and fasten the seat belts;
- (g) have accepted and agreed the Circuit regulations;
- (h) have signed the PIRELLI’s release;
- (i) if the Driver is participating with a private Vehicle registered to a third party, the Driver must produce a written declaration authorising them to drive it, signed by the registered owner of the Vehicle (as stated in the log book/vehicle registration certificate).



**1.2** It is strictly prohibited for any Driver to access the track and/or paddock in a psychically altered state (merely as an example, due to having consumed alcoholic drinks or drugs that can reduce concentration/induce sleepiness), until the driving activities have been concluded.

**1.3** It is strictly prohibited for any Driver to use a vehicle other than the Vehicle indicated in the Pass to be shown upon entry.

**1.4** Drivers are allowed to transport a Companion as a passenger on the Vehicle involved in the track sessions under the following conditions:

- (a) the passenger must be at least 18 years of age;
- (b) the passenger must sign the PIRELLI's release
- (c) the passenger must sit next to the Driver;
- (d) the passenger must wear his/her own validly homologated automotive helmet and balaclava and fasten the seat belts.

It is absolutely forbidden for the Drivers to start any track session with a passenger, in the absence of delivery to PIRELLI of the duly completed PIRELLI's release.

**1.5** It is strictly prohibited for those accompanying the Driver to access the track.

**1.6** It is strictly prohibited for the Driver and for those accompanying them to bring any animal to the track and paddock.

**1.7** The P ZERO™ Experience Package is purchased on an individual and personal basis; it may in no way be transferred to third parties.

**1.8** The Driver has to drive all vehicles at walking speed on all access and connecting roads and in the paddock.

## **2. COMPANIONS**

**2.1** The Driver expressly acknowledges and accepts that:

- (i) only 1 (One) Additional Driver is allowed, exception made for Voucher's Beneficiary for whom NO Additional Driver is allowed;
- (ii) the maximum number of Companions is 3 (three);
- (iii) children under 14 are not allowed to access to the P ZERO™ Experience; and
- (iv) in the event that the Companion(s) are minors (i.e. from 14 to 17 years old), a supervising adult Companion must also be present (included in the maximum number of 3 companions).



**2.2** The Driver agrees that he/she shall procure that his/her Companion(s) will respect these Regulations and the regulations of the Circuit under penalty of exclusion from the P ZERO™ Experience pursuant to the following section 3.1. In case of breach of these Regulations by the Companion(s), PIRELLI shall have the right to exclude the Companion(s) from the participation in the P ZERO™ Experience, in accordance with section 3.

### **3. RIGHT OF EXCLUSION**

**3.1** PIRELLI reserves the right to exclude from participation in the P ZERO™ Experience any Driver who does not respect the provisions of sections 1.1 and/or 1.2, who has made false statements, or not presented the documentation requested for the registration process, capable of proving their possession of said requirements, or whose Vehicle does not match the description in the "Pass" to be shown upon entry. PIRELLI also reserves the right to exclude from the participation those accompanying persons who do not have the requisites referred to in sections 2.1 and 2.2 and/or do not follow the instructions by the personnel of Pirelli or of the Circuit and/or should breach these Regulations and/or the regulations of the Circuit.

**3.2** In the event of serious or repeated breaches of the instructions received from the appointed personnel of PIRELLI and/or the Circuit, or for repeated behaviours which could affect the safety in the activities and/or impair the proper performance of the services provided to the other participants, persons responsible for such behaviour may be excluded from the programmed activities. In case of this "disciplinary" exclusion, there will be no reimbursement of the amount paid.

### **4. CIRCUIT'S SECURITY SURVEILLANCE CAMERAS**

**4.1** Drivers acknowledge, also for those accompanying them, that the facilities are monitored by security surveillance cameras of the Circuit, and that recordings of persons are stored and processed by the security surveillance cameras of the Circuit with IT support and, if necessary, used to investigate criminal behaviour, accidents, damage and/or other comparable incidents. ### **5. COSTS NOT INCLUDED**

**5.1** Board and lodging costs of any kind, costs for extra services, costs of travelling to and from the Circuit, fuel, maintenance and insurance costs for own vehicles and all those costs not specifically mentioned in the terms and conditions of sale of P ZERO™ Experience Packages and of the Gift Vouchers are not included in the registration cost.

### **6. LIABILITIES OF THE DRIVER**



**6.1** The Driver assumes full liability, in all eventualities, for the truthfulness of the information provided at the time of registration and in any subsequent request made by PIRELLI, the Circuit and/or the operators of the P ZERO™ Experience.

**6.2** Participation in the P ZERO™ Experience is at the (Driver's) own risk. The vigilance of the staff of Pirelli and of the Circuit during the activities in no way constitutes assumption of liability by the personnel in question or by PIRELLI for any damages caused by the Driver and/or his/her Companions (if any).

**6.3** The Driver assumes any and every liability, without exclusion or exception, in civil, criminal or administrative proceedings, for any damage to things or to people, including those transported, and for any breach of the current regulations as a result of the use of the Vehicles in question.

**6.4** The Driver undertakes to pay directly or, otherwise, to reimburse the sums requested to him/her, or that the Driver might be sentenced to pay as a result of accidents, incidents, or breaches as stated above.

## **7. TEST DRIVE OR HOT LAPS WITH CAR MANUFACTURES**

The Driver and/or any of his/her Companion(s) who wish to attend any activities (including test drive or hot laps) with the car manufacturers attending the P ZERO™ Experience shall have to abide by any instructions and/or regulations requested by such car manufacturers and their personnel.

PIRELLI shall not be liable for any damages incurred by the Driver and/or by any of his/her Companion(s) during and/or in relation to any activities (including test drive or hot laps) with the car manufacturers attending the P ZERO™ Experience; accordingly the Driver - also on behalf of his/her Companion(s) - agrees to release and save Pirelli harmless from any liability with respect to any claims arising out of or in any way connected with such activities and waives any claim or action against PIRELLI in relation thereof.
